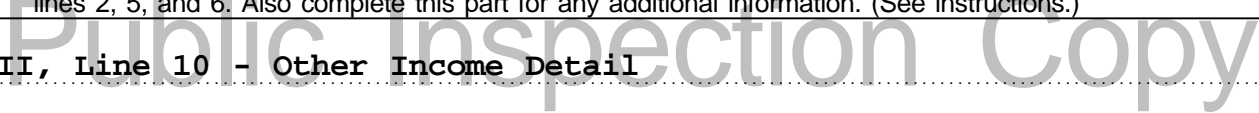

At that time, all Board members are required to complete these forms, which are kept in the organization's records. Any new Board members who are appointed during the year are given copies of the policy and it is discussed during their orientation. As a result, there is a high level of awareness and sensitivity among Board members to any potential conflict. We have required this disclosure by Board members for a number of years, and as of 2012 we have extended this practice to key employees.
